Ordinance No. 19-03-19-01

AN ORDINANCE AMENDING SECTION 70.15 AUTHORITY TO INSTALL TRAFFIC CONTROL DEVICES OF THE WILMINGTON CODE OF ORDINANCES

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF WILMINGTON, WILL COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. That Section 70.15 – Authority to Install Traffic Control Devices - of the Wilmington Code of Ordinances be and is hereby amended with the addition of the following provision:

Stop Signs:

- Chicago Street west bound lane (sign placement on north side of street)
- N. Water Street north bound lane (sign placement on N. Water St prior to turning east on Chicago St
- N. Water Street at Mill Street south bound lane (sign placement on west side of street)
- S. Kankakee Street at Ryan Street north bound lane (sign placement on east side of street)
- S. Kankakee Street at Ryan Street south bound lane (sign placement on west side of street)
- Jackson Street at Mitchell Street east bound lane (sign placement on south side of street)
- Jackson Street at Mitchell Street west bound lane (sign placement on north side of street)
- East Street at Fulton Street south bound lane (sign placement on west side of street)

SECTION 2. SEVERABILITY This Ordinance and every provision thereof, shall be considered severable. In the event that any court of competent jurisdiction may find and declare any word, phrase, clause, sentence, paragraph, provision or section or part of a phrase, clause, sentence, paragraph, provision or section of this Ordinance is void or unconstitutional, the remaining words, phrases, clauses, sentences, paragraphs and provisions and parts of phrases, clauses, sentences, paragraphs, provisions and sections not ruled void or unconstitutional shall continue in full force and effect.

SECTION 3. REPEALER All Ordinances or parts of Ordinances in conflict with any other provisions of this Ordinance shall be, and the same are hereby repealed.

SECTION 4. EFFECTIVE DATE This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
